### Travel Arrangements Disclaimer:

2GHK is not a travel agency and does not provide travel services. While we will share suggested flights and accommodation options for coordination purposes, members are responsible for making their own travel bookings. This includes:

### Registration Process:

1. Registration is exclusive to 2GHK members
2. Members may refer personal friends (subject to approval)
3. All referred guests must register through their 2GHK member referee
4. Submit registration form with participant details
5. Pay deposit of HKD 5,600 (share room) / 7,600 (own room) per person

The HKD 5,600 / 7,600 deposit will be collected to cover shared expenses including:

- \* Local transportation
  - \* Group meals
  - \* Cultural activities
  - \* Local guide services
  - \* Exclude air tickets
- A detailed breakdown of all shared expenses will be provided post-trip
  - Any remaining balance from the expense pool will be retained by 2GHK as administrative costs
  - Additional costs beyond the deposit may be required, depending on final arrangements

### Non-Refundable Policy:

- The HKD 5,600 / 7,600 deposit is non-refundable upon submission
- In case of withdrawal:
  - \* The deposit cannot be transferred to another person or future event
  - \* No refund will be provided regardless of the reason for cancellation
  - \* This policy ensures commitment and helps maintain the integrity of our group arrangements
